5. **POSSIBLE ACTION ON APPROVAL OF MINUTES - September 12, 2018** (4:31:20) - Chairperson Kimbrough introduced this item, and entertained a motion. Vice Chairperson Bonkowski moved to approve the minutes, as presented. Member Bagwell seconded the motion. Motion carried 6-0.

Chairperson Kimbrough entertained questions or comments of the CAMPO members and of the public and, when none were forthcoming, a motion. Vice Chairperson Bonkowski moved to award the distribution of Federal Fiscal Year 2018 Federal Transit Administration 5310 grant funds, in the amount of \$135,665, to the Carson City Regional Transportation Commission. Member Bagwell seconded the motion. Chairperson Kimbrough entertained discussion on the motion and, when none was forthcoming, called for a vote. Motion carried 6-0.

6(B) POSSIBLE ACTION TO AWARD THE DISTRIBUTION OF FEDERAL FISCAL YEAR 2018 FEDERAL TRANSIT ADMINISTRATION 5339 GRANT FUNDS, IN THE AMOUNT OF \$133,626, TO THE CARSON CITY REGIONAL TRANSPORTATION COMMISSION (4:33:43) - Chairperson Kimbrough introduced this item, and Ms. Maloney presented the agenda materials. Mr. Dollarhide acknowledged the grant funds represent partial funding. Member Macquarie requested staff to evaluate the opportunity for electric vehicles when considering new vehicle purchases. He acknowledged the initial cost would be higher, but suggested that, in consideration of life cycle costs, "they could well be cheaper." Member Macquarie expressed the opinion that his suggestion would "fit in very well with" the One Nevada Plan's goal of sustainability. In response to a comment, Ms. Maloney advised that staff would consider all options, before entering into contract, relative to future bus purchases and transit planning.

Chairperson Kimbrough entertained additional questions or comments of the CAMPO members and of the public and, when none were forthcoming, a motion. Member Bagwell moved to award the distribution of Federal Fiscal Year 2018 Federal Transit Administration 5339 grant funds, in the amount of \$133,626, to the Carson City Regional Transportation Commission, based on the evaluation criteria. Member Stedfield seconded the motion. Chairperson Kimbrough entertained discussion on the motion and, when none was forthcoming, called for a vote. Motion carried 6-0.

6(C) INFORMATION ON THE FINAL REPORT FOR THE FISCAL YEAR 2018 TRIENNIAL REVIEW OF THE CARSON AREA METROPOLITAN PLANNING ORGANIZATION (4:38:41) - Chairperson Kimbrough introduced this item. Mr. Dollarhide presented the agenda materials, and responded to questions of clarification. Chairperson Kimbrough entertained additional questions or comments of the CAMPO members and of the public; however, none were forthcoming.

**6(D) NEVADA DEPARTMENT OF TRANSPORTATION STAFF PRESENTATION OF THE ONE-NEVADA PLAN** (4:41:45) - Chairperson Kimbrough introduced this item. NDOT Transportation Planner / Analyst Tim Mueller thanked Ex-Officio Member Rosenberg "for being the NDOT Champion for the One Nevada effort." Mr. Mueller acknowledged Member Bagwell's attendance at the mobile workshop which was held in September; Vice Chairperson Bonkowski's participation in the Carson City freeway opening ceremony; and Chairperson Kimbrough's service on the Statewide Transportation Technical Advisory Committee. Mr. Mueller presented the agenda materials. Mr. Mueller and Ex-Officio Member Rosenberg responded to questions of clarification. Ms. Maloney discussed the benefits of Transportation Division staff having participated in the process.

Chairperson Kimbrough entertained additional questions or comments of the CAMPO members and of the public; none were forthcoming. Ex-Officio Member Rosenberg advised that the draft plan is available on NDOT's website, and requested everyone to review it and provide feedback.

**Agenda Title: (For Possible Action**) To support the statewide performance targets for Pavement, Bridge, System Performance, and Freight performance measures established by the Nevada Department of Transportation (NDOT).

**Staff Summary:** NDOT has established Pavement, Bridge, System Performance, and Freight performance targets in accordance with the FAST Act. Metropolitan Planning Organizations (MPOs) such as CAMPO are required to either support the State's targets or adopt their own. Staff will provide an overview of the performance measures and statewide targets.

Agenda Action: Formal Action/Motion Time Requested: 5 minutes

#### Proposed Motion

Move to support the statewide performance targets for Pavement, Bridge, System Performance, and Freight performance measures established by the Nevada Department of Transportation (NDOT).

#### Background/Issues & Analysis

The U.S. Department of Transportation (DOT) Federal Highway Administration (FHWA) established the Pavement and Bridge Condition Performance Measures (PM) Final Rule and the System Performance/Freight/CMAQ Performance Measures Final Rule. The Final Rules provide performance measure requirements for target-setting.

The performance measures contained within the Pavement and Bridge Condition PM Final Rule and within the System Performance/Freight/CMAQ PM Final Rule, as applicable to the CAMPO planning area, are below. NDOT has established statewide performance targets, which are also shown.

- Percentage of Pavements of the Interstate System in Good Condition
  - Statewide Target: >=95.0%
  - Statewide Status: 86.7%, reported annually
- Percentage of Pavements of the Interstate System in Poor Condition
  - Statewide Target: <=5.0%
  - Statewide Status: 0.3%, reported annually
- Percentage of Pavements of the Non-Interstate National Highway System (NHS) Classified as in Good Condition
  - Statewide Target: >=95.0%
  - o Statewide Status: 94.5%, reported annually

- Percentage of Pavements of the Non-Interstate National Highway System (NHS) Classified as in Poor Condition
  - Statewide Target: <=5.0%

- Statewide Status: 0.3%, reported annually
- Percentage of National Highway System (NHS) Bridges Classified as in Good Condition
  - Statewide Target: >35% (surface distresses, as a percentage of deck area)
  - o Statewide Status: 43.3%, reported annually
- Percentage of National Highway System (NHS) Bridges Classified as in Poor Condition
  - Statewide Target: <7.0% (surface distresses, as a percentage of deck area)
  - Statewide Status: 0.5%, reported annually
- Percent of the Person-Miles Traveled on the Interstate that are Reliable
  - Statewide Target: 85.0%
  - Statewide Status: 90.8%, reported annually
- Percent of the Person-Miles Traveled on the Non-Interstate National Highway System (NHS) that are Reliable
  - o Statewide Target: 65.0%
  - Statewide Status: 85.4%, reported annually
- Truck Travel Time Reliability (TTTR) Index
  - Statewide Target: <=1.5
  - Statewide Status: 1.4, reported annually

**Target-Setting Process:** The Pavement and Bridge Condition PM Final Rule and the System Performance/Freight/CMAQ PM Final Rule establish the process for the State Departments of Transportation (DOTs) and Metropolitan Planning Organizations (MPOs) to set and report targets. MPOs shall establish these performance targets for each of the measures no later than 180 days after the State establishes their performance targets. These performance targets were submitted by the State on May 20, meaning that MPOs must establish targets no later than November 16.

**CAMPO Performance Measure Targets:** The specific performance measures outlined within the Final Rules described above apply to interstates and non-interstate National Highway System (NHS) roadways. As provided within the NHS map for the CAMPO Planning Area (see Supporting Material, attached), the roadways to which these performance measures apply are owned and maintained by NDOT. It is required that CAMPO either support the State's targets or adopt our own, however, since neither CAMPO nor the partner jurisdictions (Carson City, Lyon County, Douglas County) maintain these roadways, CAMPO staff recommend that the CAMPO board support the statewide targets for this reporting period.
